Ron Lucas will begin radiation treatments on Monday, February 16. Please continue your prayers for these treatments to be effective, giving thanks for the Lord's presence and for the provisions Ron & Sue have seen.

Earl Mokma's bone marrow biopsy results show that his leukemia has increased significantly. This means that his leukemia is no longer responding well to the chemo treatments - it is killing off his good cells instead. There are not alternative chemo options for his form of leukemia and since he is not a candidate for stem cell replacements, Earl plans to meet with doctors in the coming week to consider the possibility of clinical trial treatments. His care page update shares this as well: *"While this wasn't the news we anticipated hearing today, please pray for peace in the decision to move forward with the clinical trial, that if dad is accepted into a trial that these treatments will be effective against his leukemia, and that the information that they learn from this trial could be beneficial for future treatments for those who are diagnosed with leukemia. Dad has said since this journey began, that God had his day's numbered before his life began. God has it all in control, not our plans, but His!! Thank you for your prayers!!"*

Ron Vos continues to be under the care of Hospice. We pray that he will continue feeling good and will know the Lord's presence and peace in the days ahead.
